



The Yuba-Sutter Fair is happening live and in person June 24 – 27. Valley Quilt Guild will again be helping in the Still Exhibits in Franklin Hall, where the quilts are displayed. This is a way we can contribute to our community, as well as getting a \$1,000 reduction of the fees we pay for the main exhibit hall when we have our quilt show. For any members who feel comfortable doing so, we need volunteers for set-up and take-down of the quilts, and also to be at the quilt table in Franklin Hall during the fair. Being at the table involves selling raffle tickets, accepting quilt blocks, answering questions about the guild and giving a membership application if appropriate, and reminding people about not eating and no touching the quilts as they look at the exhibits. We do this in shifts – 3 shifts per day, 3 people per shift. The last time we did this we needed 36 volunteer slots to be filled. Please get together with a couple friends and volunteer for a shift!

The fair also needs quilt entries. The entry deadline is May 25. You can enter online at ysfair.com or you can send in a paper entry form. The fee for each quilt is \$2.00. Quilts need to be delivered to Franklin Hall at the fair June 11, 2 pm to 8 pm and June 12, 9 am to 6 pm. Judging is closed to the public and takes place on June 13 at 9 am.

The guild needs entries in the block contest. We use these to make the quilts that are raffled off the next year. There is no fee to enter, and no entry limit. Entries are to be delivered to the Quilt Table in Franklin Hall by 3:30 pm on Saturday, June 26, 2021.

 - Measures less than 48" on the longest side. Hand or machine pieced, and hand quilted by maker.
- 4 Large Quilt-
 - Measures 71" or more on the longest side. Machine pieced and machine quilted by maker.
- 5 Medium Quilt-
 - Measures 48" to 70" on the longest side. Machine pieced and machine quilted by maker.
- 6 Wall Quilt-
 - Measures less than 48" on the longest side. Machine pieced and machine quilted by maker.
- 7 Large Quilt-
 - Measures 71" or more on the longest side. Machine pieced and hand or machine quilted by another.
- 8 Medium Quilt-
 - Measures 48" to 70" on the longest side. Machine pieced and hand or machine quilted by another.
- 9 Wall Quilt-
 - Measures less than 48" on the longest side. Machine pieced and hand or machine quilted by another.
- 10 Large Quilt-
 - Measures 71" or more on the longest side. Group quilt
- 11 Medium Quilt-
 - Measures 48" to 70" on the longest side. Group quilt.
- 12 Wall Quilt-
 - Measures less than 48" on the longest side. Group quilt.
- 13 Quilt – Any Other (specify)

Zoom Meeting

May 10, 2021

A meeting of the Valley Quilt Guild Board was held on May 10, 2021. It was an online meeting using the ZOOM application since the pandemic quarantine is still in effect. It was called to order at 4:02 pm.

Before addressing the regular meeting agenda Colleen made special mention of the importance of timeliness in getting newsletter articles to Leann Welden. Please notify her if you are going to be late getting something in.

Secretary: A motion to approve the minutes of the last meeting was made by Nicki Lura and seconded by Deanna Williams. A unanimous vote followed.

Correspondence – We have a letter from Adventist Health requesting Fidget Quilts for their dementia patients. Our last sew day several members made fidget quilts and they will be ready to donate soon.

Treasurer's Report: We have a savings balance of \$19,997.71, a quilt show balance of \$5,000.00, a Tri-Counties Bank checking balance of \$1140.83 and a River Valley Bank checking balance of \$1020.00. The Tri-Counties Bank Checking account will be closed with the remainder being moved to River Valley Bank after the last check clears.

Old Business:

Pat Smith, Quilt Show Treasurer for 2021 has closed the books for the 2021 show. All money over the \$5000.00 start-up amount for the 2022 show has been moved to Quilt Guild funds.

Fair – We have several people signed up to work set-up and to cover shifts, but we still need more. Colleen will send out a reminder hoping for more sign-ups. Deadline for entries is May 27, 2021. Colleen will send out another reminder for this too!

Election of Officers – 2021 – 2022 proposed officers on the slate are Colleen Pelfrey, president, Michelle Jones, 1st Vice President, Pat Smith, 2nd Vice President, Terry Nugent, Secretary, and Jan A Thompson, Treasurer. A vote will occur at the May 26 Guild Zoom Meeting by Zoom Poll.

Bank change – We are moving all Guild money from Tri-Counties Bank to River Valley Bank. It was discussed and decided that the signatures required on our new bank accounts should conform with what is usual for non-profit organizations. This required one change – It was moved by Eileen Milligan and seconded by Pat Smith that when the new Quilt Show account was moved to River Valley Bank the three signatures on that account would be the Quilt Show Chairman, the Quilt Show Treasurer and the Quilt Guild Treasurer. This motion was passed with a unanimous vote by the Board. This change does not affect the duties of the Quilt Show Treasurer, but enables the Quilt Guild Treasurer to view all Guild money. Janet Craver is working on getting all accounts set up with appropriate signatures on file.

July Meeting – We would like to hold the Ice Cream Social in July or August. Diane Leighton will check with St. Andrews Presbyterian Church to see if it is open to this in either month.

Christmas Party venue – Since Whittaker Hall has said they are not open for use for the remainder of the year and the Courthouse Café is closed we are looking at other possible venues. Colleen is looking into the Moose Hall to see if it is available and if the price would be reasonable.

New Business:

Membership dues for 2021-2022 year. Membership forms will be in the next newsletter and will be returned with a check to the Valley Quilt Guild PO Box – Attention Membership Chair. These forms and money will go directly to Nicki Lura for processing.

Committee Members – Colleen will be in contact with all committee members not present for today's Board Meeting to see if they are willing to continue in their current positions.

Budget Input – Officers and chairpersons need to be considering their needs for the next year. We need to have figures for a one-month July budget to hopefully vote on at the June Board Meeting so please get those figures to Colleen as soon as you can.

Any bills need to be submitted to the treasurer by the June Board Meeting.

Vice President's update: Our May meeting zoom speaker will be Trudy Cleveland telling us how to photograph our quilts successfully. Michelle Jones is looking into possibilities for June.

Community Service: Diane Leighton says quilts are continuing to trickle in.

Opportunity Quilt: The quilt is set to visit a couple of small guilds and Deanna is working on the paperwork to take it to the Reno Quilt Show in June. She is open to suggestions if anyone has somewhere to show the quilt and sell opportunity tickets.

Membership: No new members this month – next year membership drive is set to start soon.


